You may already know that FOMOS presented at both the May and June Property Committee (PC) meetings, requesting an 8-week extension to our proposal deadline. This was passed unopposed, only to be denied 48 hrs later at Council. With 5 of the 7 Council members also sitting on the Property Committee, this was an unexpected and disappointing turn of events.

Further adding to the rollercoaster-iness, as the meat sandwiched between those two events, was the lengthy <u>Expositor article</u> detailing Central's revived plans for a recreation complex to be located adjacent to the township office. That this plan is yet again rearing its contentious head, was unexpected news to FOMOS.

Given the absolute relevance floating the concept of a new hockey arena in Central has on how FOMOS proceeds, that we were not advised of this subcommittee's existence immediately upon gaining our mandate at the beginning of the year, or indeed at any time thereafter, was rather a blow to the trust we thought we were building with the township, the property committee and council itself.

Ultimately, it was a deeply disheartening week, but despair not for like the <u>Phoenix</u>, FOMOS has risen again, licked its wounds and with renewed vim resumed its rally around our objective and let us just tell you that we are SO thrilled that we have you, our membership, many in number and committed in action, behind us!

Not to keep harping on this, but we really do have to say it once more: We have such a dedicated and **amazing group of volunteers!** There is zero way we would have come as far as we have were it not for these truly invested folks. **You are all incredible!** 

The renowned American cultural anthropologist, <u>Margaret Mead</u>, famously said: "Never doubt that a small group of thoughtful committed citizens can change the world" and while we may not be changing the world per se, in our endeavour to save the Old School we **are** hoping to at least steer a small bit of its local course in a positive, green and common-sense direction.

## FOMOS PRESENTS AGAIN (and again and again and again...)

We thought you might want the rest of the spicy details of the presentation we talked about in the editorial above (yeah, we have an "editorial" now. Fancy!), so here goes:

Board member Alison McAllister once again presented to the Property Committee on May 11. She briefly described the progress we have made in a number of areas, addressed some administrative frustrations we have been experiencing regarding gaining access to the Old School as these relate to communications between us and the township.

Alison also briefly spoke about Canadian Builder (a local real-estate developer) and closed by requesting an 8-week extension to our proposal deadline. Councillor Tribivenicius commented that he is pleased with our progress, while Councillor Scott asked a few questions and commented that in reading between the lines, he inferred that we believe the township to not be acting entirely in good-faith when dealing with FOMOS, a notion to which he vigorously objected. Alison politely and eloquently refuted any such implication. Eventually Councillor Johnston, seconded by Councillor Diebolt moved that the extension be granted and the motion was passed unanimously.

# LOCAL DEVELOPER OFFERS TO REVITALIZE OLD SCHOOL AS SENIORS HOUSING (Or: So what is the deal with Canadian Builder?)

Earlier this year, having followed the media's coverage of our struggle to save the Old School, *Canadian Builder Inc.*, a well-renowned real-estate developer based in Sudbury, made itself known to FOMOS and through a series of informal interactions with us, laid out their vision and intent vis-a-vis the Old School building. A vision for which they sought our support.

Canadian Builder has extensive experience converting decommissioned, public spaces (old schools, fire stations etc.) into residences with the specific goal of increasing the availability of high-quality, accessible and affordable rental units. When they learned about the Mindemoya Old School they were intrigued and set out to learn more.

At the beginning of June, having completed their due diligence, Canadian Builder submitted an offer for the building to the Township of Central Manitoulin, simultaneously sending a courtesy copy to FOMOS. We have reviewed the offer and our assessment of its alignment with our mandate and are of the opinion that first and foremost it meets with our primary objective of preserving the historical building while also a secondary, very important municipal need by increasing desperately needed rental housing in our community.

But wait - there's more! This offer also creates an opportunity to establish a vibrant community-hub and beautify Mindemoya's main street, while helping reduce our local carbon-emissions and as an added bonus, the building itself will of course eventually become a property-tax generating entity. All of this at a fraction of the cost (and effort) that meeting these objectives could otherwise pose to Central's rate-payers.

For these reasons, we have informed Council that Canada Builder's offer has our unqualified support and it is our very sincere hope that Council either accepts it as presented or, in the alternative, opts to present Canadian Builder with a reasonable counter-offer.

#### OFFICE & ADMINISTRATION & YOUR APPEAL LETTERS

Earlier this week we sent an urgent plea to our entire membership asking you to voice your individual support for the Canadian Builder purchase offer directly to the township. And boy - you guys are a reliable bunch - you have shown up in droves!

We want to take a moment to thank the many people who have sent letters of support to the Municipality. Naturally, many of you are curious about the offer details. Unfortunately, as FOMOS is not a formal party to the offer, we are unable to discuss any particulars of the offer until either the Municipality or Canadian Builder decide to make this information public.

Hopefully after the Office/Administration meeting, Tuesday June 22, the Municipality will provide some more detailed information regarding its intentions for the School. Our goal with the letter-writing campaign was to make it clear to Council that FOMOS and its rate-paying, municipal election-voting membership, support an offer to enable a constructive future for an important monument to our local history.

While it's unlikely that we will learn new information relevant to our cause, by attending this meeting, by attending we show a united front in support of Canadian Builders offer and our attendance also informs Council that we are actively involved, dedicated and serious about what happens on a legislative level in our community.

**EXTRA! READ ALL ABOUT IT!:** Our cause suffered a temporary set-back when the Office/Administration Committee passed a motion recommending to Council that the Municipality not accept Canadian Builder's offer to purchase. The committee also motioned that the Offer to Purchase be made public. (presumably after the June 24th council meeting).

What is perhaps the most crucial council meeting yet for the fate of the Old School takes place on tonight, Thursday, June 24 at 19:00. We hope that lots and lots of you will be able to attend via Zoom.
